I, <u>ZACHARY D SMITH</u>, do solemnly swear that I have good reason to believe and do believe, that <u>RHONDA KYLE</u>, on or about the <u>6</u> day of <u>FEBRUARY</u>, <u>2023</u>, unlawfully committed the offense of <u>PC 22.01(a)(1) ASSAULT - FAMILY</u> <u>VIOLENCE \* - M/A</u>, such belief is based upon the following facts, to wit:

On 02/06/2023 at approx. 1833 hours, I, Officer Z. Smith 690 was dispatched to 1514 Nunneley Pl. Apt 112 in reference to a family disturbance.

Upon arrival, I made contact with the victim. She stated that her mother, Rhonda Kyle (SU) had assaulted her. The Victim stated that she and her mother live together in the same household. She stated that she was sitting on the couch in the living room arguing with Rhonda. The victim said that Rhonda walked over to the couch that she was on and swung a box of Vanilla Wafers at her face. She stated that Rhonda hit her in the left cheek with the box of Vanilla Wafers. She stated that she felt pain from being hit in the face with the box of Vanilla Wafers but said that she did not want to press charges. I did not see any visible marks or injuries on the victim's face.

I then spoke with Rhonda Kyle. She advised that her daughter got home and began yelling and cursing at her. She advised that her daughter was sitting on the couch calling her names. Rhonda advised that she walked over to the victim and hit her in the head with a box of Vanilla Wafers. She stated that the victim then stood up and punched her twice. Rhonda said that she then called the Police.

To prevent further family violence from occurring, I placed Rhonda under arrest for P.C 22.01 Assault Family Violence M/A. Rhonda was then transported to WCSO without incident.

A Records check revealed that Rhonda did not have any prior convictions for AFV.
